



## V PHOTOGRAPHIC CONTEST “PUREBRED MENORCA HORSE” CONDITIONS

### **Participants**

Photography amateurs and professionals of any range of age or origin can participate. Participating in this competition implies accepting all the conditions.

### **Theme**

The theme of the works presented is going to revolve around the Purebred Menorca Horse. It has to be present on the photos clearly but it does not need to play the main role.

### **Cómo participar**

Each participant can send a maximum of 3 photographs. All of the photographs have to be never published previously in any form; neither has participated in any previous editions of this contest.

The works can be delivered in IT format (CD or DVD) at the office of the Breeders Association or by web (<https://www.wetransfer.com>) to the following e-mail. The 3 photographs that participate in the contest must be sent to the next contact [concursofotosprme@gmail.com](mailto:concursofotosprme@gmail.com).

The present rules will be properly filled in (scan, complete, sign and send the file) and attached to the photographs. Moreover, a title and the name of the animals that appear on the photo must be indicated in each picture.

**The deadline to present the originals is the 15<sup>th</sup> April 2018.** The works presented subsequent to that date will not be accepted.

### **Requirements of photographs in digital format**

The participants can present works in colour, in sepia effect and in black and white. They will also be responsible for third people rights and complaints for image rights.

All the photographs must have enough quality for its printing. So, images are going to be exclusively accepted in format \*.jpg, with a minimum size of 1500x2300 pixels, and a maximum of 10MB and at least 200ppp of resolution. It is essential to keep ordinary proportions of photographic format.

Images with contents damaging the current laws will not be admitted.

### **Verdict**

The Jury is composed by: 2 experts on photography and 3 members of the Direction of the Breeders Association.

The selection of the finalist works is going to be done without knowing the author's name to safeguard the principles that rule the conditions of equality of the participants. During the display of the photos in the presence of the members of the jury, it is going to be indicated only the title of the work and the names of the animals.

It is going to be appreciated the idea expressed in the picture according to the objectives of the contest as well as its artistic expression and its photographic quality.

If the jury considers a work does not have the indicated conditions for its printing it is going to be disqualified of the running contest.

The judges' decisions will be final. They will be published on the *XXII Purebred Menorca Horse Fair* during the awards ceremony and also on an exhibition with the short-listed photographs.

### **Awards**

First prize: 100 € and appear in the cover of the 2018 yearbook of the Association.

Second prize: 75 €

Third prize: 50 €

An exhibition of the finalist photos in paper format is going to be carried out during the celebration of the *XXII Purebred Menorca Horse Fair*.



## V PHOTOGRAPHIC CONTEST “PUREBRED MENORCA HORSE” CONDITIONS

If the winner is minor, he will be given a gift voucher to swap for photography products to the value of the prize won. Each participant will compete just for one prize, the most significant one.

### Acceptance of conditions

The registration to participate on the IV PHOTOGRAPHIC COMPETITION *PUREBRED MENORCA HORSE* implies accepting the conditions and signing over the use rights. In order to show approval the participants have to fill in this section properly.

### **ASSIGNMENT OF USE RIGHTS**

The authors of the presented photographs authorize to the Breeders and Owners Association of Menorca Horse the use, exhibition, diffusion and use of the images in the cultural activities that determines, with no time limit and indicating always the author's name. However, the author keeps his intellectual property rights according to the law 11.723.

The Breeders and Owners Association of Menorca Horses will be able to use, broadcast and print any prized or mentioned photography in this contest, with cultural but no commercial aims.

The participants are responsible to be the only authors with no third parties. As well as, they are in charge with any complaint for image rights about the photos presented in this contest.

The participation in the competition implies being fully aware of the basis, conditions and changes the Association could make and accept them.

Taking part in the competition means the accept all the present conditions as well as agreeing the organization decisions if there is any problem not included in the rules. Likewise, the participant is totally responsible for non-third parties rights on the works presented, moreover for any complaint for image rights.
